I Wayne Guppy, Mayor of Upper Hutt, make this submission on behalf of the Upper Hutt City Council (UHCC) .						
UHCC offers our strong support for the application for resource consent made by Wellington International Airport Limited to extend the Wellington Airport runway. This is a critical step in realising the economic potential for the region through greater air connectivity						
Overall, UHCC support the concept because of the economic benefits to the Wellington region that are expected to be realised if the application is approved. These benefits specifically arise from additional international tourism, an increase in international students, business productivity benefits, freight and aviation services						
A direct air service to Asia is arguably the most significant thing the Wellington region can do to realise its economic potential. As the seat of government, a global financial centre, a location for international events, and a widely recognised leisure destination; there is significant scope to increase international visitors through improved connectivity.						
We view the runway extention as one element of a broader regional growth package including growth fo technology, film, tourism, logistics and the roads of national significance (RONS) project.						
Upper Hutt is a visitor destination and an increase in tourist numbers to the Wellington region is encouraged and welcomed. Our city is a gateway to the outdoors and recreation opportunities and is therefore well-placed to attract and cater for an increase in tourist visitor numbers.						
UHCC is not in a position to comment on the specific environmental effects of the proposal. Overall we support the concept and support the economic benefits the runway extension will bring to the region and Upper Hutt. It will be a catalyst for wider regional economic growth that we believe will have a positive impact for our community.
