My submission is that:

I support the need for changes to the district plan to address flood hazards. I support the proposed plan change with regards to the rules identified above. I was critical of the provisions of the earlier withdrawn plan change as I considered that they were too rigid given the scientific and environmental uncertainties. I submit that the rules identified above provide an appropriate regime for requiring and considering permissions for areas which have been identified as potentially at risk from flood hazard from the Mangaroa River and tributaries.
