Thank you for taking the time to consider this submission.

I oppose the plan change relating to the UHCC 1/100yr flood maps for the following reasons;

- There is no description of flood depth on the map. Is it 1mm, 100mm, or 1 meter deep? This is ambiguous & misleading
- 'Ponding Area' – what does this mean? How can there be ponding on the upper catchment areas of Pinehaven Stream (eg at 25 Elmslie Road where there is a significant cross fall from the upstream to the downstream boundaries)?
- What is the basis of the Flood Maps? Are they generated from GWRC flood maps? If so then there are discrepancies in these maps that the auditor said needed to be addressed before the maps should be accepted.
- The UHCC 1/100yr flood maps do not conform to the actual topography of my, and other properties, which have been mapped by professional surveyors.
- The GWRC Pinehaven Stream sub-catchment area calculations show *far less* volume of water flowing across my property than UHCC's 1-in-100 year flood map.
- The Council's lack of engagement with local residents leaving them in the dark or ill-informed on this issue.
- The Council's (Planning department) evasiveness in responding to submitters who ask direct, specific, and pertinent questions about the issue.
- I request that Council withdraw Plan Change 42 until such time as more detailed information of the UHCC 1/100yr flood maps has been carried out by an independent auditor. The submission process must be extended to after the audit has been completed and made public, so the community can review the results and make further comment if necessary. By closing the submission process before the review is carried out, this excludes the genuine input of the community.
- These maps will form part of the District Plan, which in turn will dictate many aspects of future land management / building restrictions – and, once approved, cannot easily be challenged. This will unfairly disadvantage many property owners, and the community as a whole if they are incorrect, as expert evidence suggests.
- Finally, I wish for the opportunity to speak at a hearing in support of my submission.
